Strategic Edge, Inc.'s Gun Range Safety Rules and Warnings

1. Treat all firearms as if they are loaded. Always assume that a firearm is loaded even if you think it is unloaded. Every time a firearm is handled for any reason, check to see that it is unloaded. If you are unable to check a firearm to see if it is unloaded, leave it alone and seek assistance from someone more knowledgeable about firearms.
2. Keep the firearm pointed in the safest possible direction. Always be aware of where a firearm is pointing. A "safe direction" is one where an accidental discharge of the firearm will not cause injury or damage. Only point a firearm at an object that you intend to shoot. Never point a firearm toward yourself or another person.
3. Keep your finger off the trigger until you are ready to shoot. Always keep your finger off the trigger and outside the trigger guard until you are ready to shoot. Even though it may be comfortable to rest your finger on the trigger, it is also unsafe. If you are in motion with your finger on the trigger and stumble or fall, you could inadvertently pull the trigger. Sudden loud noises or movements can result in an accidental discharge because there is a natural tendency to tighten the muscles when startled.
4. Know your target, its surroundings and beyond. Check that the areas in front of and behind your target are safe before shooting. Be aware that if the bullet misses or completely passes through the target, it could strike a person or object. Identify the target and make sure it is what you intend to shoot. If you are in doubt, DON'T SHOOT!
5. Know how to properly operate your firearm. It is important to become thoroughly familiar with your firearm. You should know its mechanical characteristics including how to properly load, unload and clear a malfunction from your firearm. Obviously, not all firearms are mechanically the same. Never assume that what applies to one make or model of a firearm

is exactly applicable to another. You should direct questions regarding the operation of your firearm to your firearms dealer, or contact the manufacturer directly.

6. Strategic Edge, Inc. reserves the right to prohibit the use of any firearm or accessory deemed, by instructors, to pose a risk.
7. Strategic Edge, Inc. reserves the right to exclude any student who is unable or unwilling to comply with safety rules, range rules, and/or directions.

Waiver of Liability and Hold Harmless

1. In consideration for receiving permission to participate in Strategic Edge, Inc.'s firearm courses: I hereby release, waive, discharge and covenant to release from any liability Strategic Edge Inc., its officers, Board of Advisors, owners, servants, agents, employees, instructors, safety officers, representatives, and volunteers (hereinafter referred to as "releases") from any and all liability, claims, demands, actions and causes of action whatsoever arising out of or relating to any loss, perceived loss, damage or injury, including death, that may be sustained by me, or to any property belonging to me, whether caused by the negligence of the releases, or otherwise, while participating at the Gun Range or any use, enjoyment, or presence upon the premises.
2. I am fully aware of risks and hazards connected with being on the premises and participating in the Gun Range, and I am fully aware that there may be risks and hazards unknown to me connected with being on the premises and participating in the Gun Range, and I hereby elect to voluntarily participate at the Gun Range, to enter upon the above named premises and engage in dangerous activities knowing that conditions may be hazardous, or may become hazardous or dangerous to me and my property. I voluntarily assume full responsibility for any risks of loss, property damage or personal injury, including death, that may be sustained by me, or any loss or damage to property owned by me, as a result of my being a participant or on the premises of the Gun Range, whether caused by the negligence of releases or otherwise.
3. I further hereby agree to indemnify and save and hold harmless the releases and each of them, from any loss, liability, damage or costs they may incur due to my participation in the Gun Range, whether caused by the negligence of any or all of the releases, or otherwise.
4. It is my express intent that this Release shall bind members of my family and spouse, If I am alive, and my heirs, assigns and personal representative, if I am deceased, and shall be deemed as a Release, Waiver, Discharge and Covenant NOT TO SUE the above named releases.

In signing this Release, I acknowledge and represent that:

- A. I have read the foregoing Release, I understand it fully, and sign it voluntarily as my own free act and deed;
- B. No oral representation, statements or inducements, apart from the foregoing written agreement, have been made to me;
- C. I am at least twenty-one (21) years of age and fully competent, and not under the influence of any alcohol, or mind/mood altering prescription drug;
- D. I understand that I will be using the facilities at my own risk. I also understand that a RSO will not always be able to protect me even if one is present;
- E. I execute this Release for full, adequate and complete consideration, intending to be bound by same.

I request admittance to the Strategic Edge Inc., Gun Range Firearm Course. I agree to comply with the safety rules, range rules, direct instructions by a RSO, and/or any policies and procedures (present and future) of the Strategic Edge Inc., Gun Range.
